I understand that the permission to charge my bank account is the same as if I had personally signed a cheque to OLOCM. I understand that my bank is responsible for the timely posting of all transactions from my account. If there are any discrepancies in the amount that has been transferred from my account in a given month, I will contact OLOCM directly for correction.
